 - iii. Photocopy of first 2 pages of the lost passport.
 - iv. Form S-1 (if any) and Birth Certificate (if any) and photocopies thereof.
 - v. Parent's Pakistani Passports, CNIC / NICOP and valid visas / Foreign Passports and photocopies thereof.
 - vi. Separate pre-paid self-addressed registered postal envelope for each applicant, if opting for postal delivery (Note down its tracking no for your record and tracking in future: High Commission / Consulate General takes no responsibility to keep its record).

- 1. In case of High Commission for Pakistan, Canberra, POSTAL MONEY ORDER / CERTIFIED BANK CHEQUE / BANK DRAFT in favor of "High Commission for Pakistan, Canberra".
